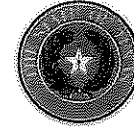

6. Discuss/Action-Law Enforcement Contract, Personnel, Budget



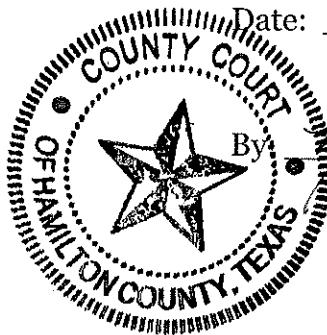
