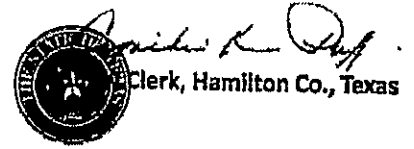



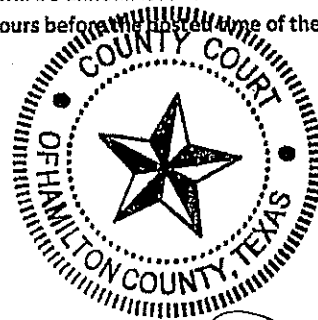
1. Call to Order and Determination of Quorum
